DIRECTIONS FROM HARRISBURG

For certain GPS devices, the site address may not be recognized. Here are the “old school” directions:

- Proceed south on South Cameron Street (Rte 230) from Harrisburg toward to Steelton.
- At the intersection of Cameron and South 13th Streets, turn right onto Elliot Street. This Street currently not marked since the street sign was damaged and has not been replaced. A good landmark is that Quigley’s Restaurant & Tavern will be on the left.
- Follow the road and across the railroad tracks. After crossing the railroad tracks, turn left and proceed to the facility gate. Please pull up to the gate and use the call box to have the gate open.
